



Industry Partner Merit Award

Concept

The Industry Partner Merit Award is the highest award that ASID bestows on an Industry Partner representative. Industry Partner representatives are elected to merit status in accordance with guidelines adopted by the ASID Board of Directors.

Eligibility

The nominee must have been an Industry Partner representative for at least five years. The importance of this honor places a serious responsibility on the chapter to submit only those nominees whose accomplishments are truly significant. Selection of award candidates will be based upon

- Outstanding and significant service to their chapter and the profession
- Exemplary service to their chapter and conspicuous contributions to the profession, having potential local, regional and/or national significance
- Contributions at the chapter level, of such importance that they have significantly enhanced the chapter and the profession
- Significant participation in chapter activities and outstanding contributions which have enriched the human experience in one or more of the following areas as they relate to the field of interior design: design, education, urban affairs, community affairs, historic preservation, research, innovation and environmental design

Nomination Procedures

Nominations may not exceed one for chapters with up to 100 Industry Partner representatives in the current calendar year; two for chapters with 101 to 200 Industry Partner representatives; and three for chapters with 201 or more Industry Partner representatives. Any chapter member may submit names for nomination to his or her chapter board with a written statement of reasons. Nominations will be made by the chapter board by a majority vote and duly recorded. If a nominee is a member of the chapter board, a vote may be taken confidentially. The co-chairs of the Industry Advisory Council will review nominations. Those nominations that meet the award criteria will be presented to the entire Industry Advisory Council for approval.

All Merit Award nominations must be received by close of business on May 15, 2009.
